## Terms and Conditions - Travel Service Fee

(Note 1) Consumption tax is included in the above fees.
(Note 2) "Travel Expenses" means the expenses to be paid to the transportation and accommodation facilities, etc. under the name of fares, accommodation charges, etc.
(Note 3) The above fees do not include telephone charges, communication charges, shipping charges, and other actual costs. Actual communication costs may be charged separately.
(Note 4) The above fees are non-refundable even if the tour is cancelled.
(1) Arrangement fees

- Arrangement" includes only ticketing without reservation.
- In the case of consecutive nights at the same facility, it will be treated as one arrangement per case.
- Arranging transportation" means arranging JR, private railways, buses, ferries, etc.
- Simultaneous arrangements for the same transportation service will be treated as one arrangement, regardless of one-way/round-trip, sector, number of passengers, etc.
- Arranging sightseeing tickets" means arranging admission tickets, meal tickets, shrine and temple tickets, etc.
(2) Change procedure fee (3) Cancellation procedure fee
- Charges will be applied for changes or cancellations after arrangements have been made. A change fee will be charged for each change.
- Arrangement fee (1) above will be collected separately
- Any cancellation fee, accommodation charge, penalty or other charges already paid or to be paid to the hotel or transportation facility shall be charged separately.
(5) Escort service fee
- Transportation, accommodation, and other expenses necessary for the tour operator to accompany the tour will be charged separately.
(6) Fees for mediation services at airports, etc
- If the service is performed between 10:00 p.m. and 5:00 a.m., or on Sundays, national holidays, or during the year-end and New Year holidays, the fee will be increased by 5,500 yen.
- Actual transportation costs will be charged separately.
